FROZEN PIPES: We all know that water freezes at 32 degrees and assume that since our living quarters never get anywhere near that cold, we have nothing to worry Unfortunately, that is about. not true – we do need to worry and take precautions when the temperature drops into single digits. The pipes in your unit run through walls that may not be as well insulated as they should have been, or across the attic where insulation coverage can vary.

When the temperature drops into single digits, allow water to trickle from faucets and showers; open cabinet doors below kitchen and bathroom sinks (and overhead kitchen cabinet doors in 2<sup>nd</sup> floor units) to allow the room's heated air into the cabinet.



Frozen pipes can burst and when the water thaws it can run in the wall, attic, and/or inside living space and can cause *tremendous* damage. Please do your part. ICE, ICE, ICE: As of this writing we are still dealing with ice and the damage the melting ice is causing. If your unit has sustained ice melt damage, please call Ron Maglieri @ 610-0165.
