Only stickered vehicles may be parked in resident lots between 6:00 p.m. and 7:00 a.m. Monday-Friday and all hours Saturday and Sunday.

If you recently moved in or purchased a new vehicle, please call Ron Maglieri to obtain a parking sticker right away.

If your vehicle is towed, you can retrieve it at Lafayette Towing (436.7131).

Also, this was noted during the annual meeting: Please try to "park smart," by not leaving huge spaces between you and the vehicle next to you. Leaving big gaps decreases the number of available spaces. Thank you.

MAINTAIN YOUR FURNACE

Due to the importance of this issue, we are re-running this notice from last month.

Over the last several years, we've had a high number of incidents where the Portsmouth Fire Department has been called on to the property.

It is crucial that everyone maintain their furnaces. Furnaces (especially older furnaces) need maintenance every year, on a regular schedule.

If you haven't had your furnace maintained this year, now is the time before winter comes and the heat is running regularly.

Every unit should also have a carbon monoxide detector.

Please call us with any questions. This can be a matter of life and death.

When It Snows

- (1) Please leave cars in parking lots during the storm **until the snow has stopped completely**.
- (2) Once the snow has stopped <u>and</u> the road has been plowed to its full width, please move your car as soon as possible to the clubhouse parking lot or the right side of the exit road, so that all parking spots can be plowed at once.
- (3) Please **do not park along the edge of the road at the circle**, as the road is too narrow there for plows to pass.
- (4) Never block the walkways.
- (5) If you are going to be out of town or unable to move your car during a snow event, please leave your car in the clubhouse parking lot, in a space close to the exit road.

Other Winter Notes/Preparation

- (1) Make sure your freeze alarm is installed and operational.
- (2) Please keep your unit's temperature no lower than 65 degrees Fahrenheit during the winter (as required in the Residency Rules & Regulations, No. 12).
- (3) Do not disturb the snowplow stakes; they provide guidance for snowplow operators.
- (4) Please use the five-gallon buckets of sand/salt mix to alleviate any icy or slippery conditions before venturing out onto your walkway. If the pail needs to be refilled, please contact our Property Manager, Ron Maglieri, at 610.0165.
